WARRANTY CERTIFICATE

(Industrial & commercial doors)

The material and hardware used for the fabrication of GARAGA products are of the best quality. All components or parts of the garage door system manufactured by GARAGA proven to be defective during the warranty period described hereunder will be repaired or replaced at the discretion of GARAGA. Any component that is repaired or replaced is also guaranteed, but only for the remainder time period of the initial warranty related to this part.

GENERAL LIMITED WARRANTY

GARAGA warrants that its garage doors (panels) will be free from defects in workmanship and material for a period of ten (10) years from the date of purchase from GARAGA or an authorized GARAGA distributor on the following products: G-1000, G-2020/G-2023/G-2323, G-4400 G-5000, G-5200, G-5138 and TG-6200. Products TG-8024/8524 are one (1) year.

GARAGA warrants that any part of hardware and accessories will be free from defects in workmanship and material for one (1) year from the date of purchase from GARAGA or an authorized GARAGA distributor.

WARRANTY AGAINST DELAMINATION

GARAGA warrants its garage doors (panels) against delamination of the polyurethane foam from the metal facing (steel or aluminum) for a period of ten (10) years from the date of manufacturing.

GENERAL Conditions

When purchasing a GARAGA product, the buyer accepts the present warranty and recognizes it as

being the only official warranty, thereby excluding any other representation, warranty or conditions, whether written or implied, offered by whomever, except if stated in writing by a GARAGA authorized agent.

The warranty offers full coverage for the first year, with an annual decrease of the coverage based on the pro-rata of the elapsed number of years against the number of years of the particular warranty after that. The value of the warranty is calculated on the selling price paid by the authorized distributor at the date of the claim.

These warranties are subject to the following restrictions:

- the product has not been modified;
- the material has been used under normal operating conditions;
- the product has been properly installed, subject to an inspection by an authorized GARAGA agent.

This warranty extends only to the original purchaser of the product and is not transferable.

Claims must be submitted to the manufacturer in writing within thirty (30) days of the discovery of the alleged defect and must be received by GARAGA within the warranty period failing which, the warranty shall be deemed null and void.

These warranties expressly exclude:

- any cost related to the transportation of the replacement product;

- any installation and labour costs related to the replacement product;
- any cost related to a door that has been repainted by or for the end-user;
- any cost that the user of a GARAGA product may incur in exercising this warranty;
- any cost resulting from an accidental damage or caused by a defective material;
- any responsibility related to the change of model, material, standard colour, etc. made by GARAGA and/or its suppliers, since the date of purchase of the product.

In order to carry out its obligation, GARAGA reserves the right to provide a product of similar quality but in a different colour if unable to supply a product of same original colour or, if in GARAGA's opinion, a door of a different colour could prevent a problem from reoccurring.

The product which is replaced becomes the property of GARAGA and must be returned to it, at the user's expense, unless a special arrangement has been made with an authorized GARAGA agent.

MAINTENANCE DONE BY THE CONSUMER

The GARAGA product user commits to regular yearly maintenance as recommended by GARAGA (see instructions from manufacturer).

DISCLAIMER

Except for the warranty expressly set forth herein, GARAGA hereby disclaims and excludes all representations, warranties and conditions, whether written or oral, implied, statutory or otherwise with respect to its products and all components and elements thereof, including, without limitation, implied warranties and conditions of merchantability and fitness for particular purpose, including any and all warranties and conditions found in the applicable sale of goods acts.
